Nonresidents are charged the same fees as charged Alabama residents to fish in their state, but not less than twice the cost for said license that Alabama residents pay.

AOS - all other states

**All licenses require an additional \$1.00 issuance fee.** Disabled license only \$1.00 issuance fee. Licenses may be purchased by enclosing a money order for the license and issuance fee and mailing to:

There is no application form. Applicants for shrimp boat and purse seine licenses must include the registered vessel name or state registration number. A copy of the owner's driver's license is needed. Prior to purchasing a live bait dealer license, the person's boat, truck, or place of business must be inspected. Nonresident licenses may be purchased at Marine Resource Division offices at Dauphin Island, Bayou La Batre, and Gulf Shores.

The Alabama Legislature passed into law Act 95-287 which changes the law with regard to eligibility to purchase a commercial gill net license in 1995 and subsequent years. In order to qualify to purchase a license, the applicant must show that he (a) purchased a license in two of five years during the years 1989 to 1993 and provide proof in the form of original unamended income tax returns that at least 50% of his income was derived from the capture and sale of seafood species (commercial fishing) or (b) that he purchased a license in each of the years 1989 to 1993 and paid his applicable Alabama income taxes in each of the years 1989 to 1993.

Live bait dealer licenses may be purchased only from the Dauphin Island office. Other resident licenses may be purchased at county courthouses and selected agents.

Louisiana residents must also purchase a recreational freshwater fishing license in addition to the recreational saltwater license.

Exempt Categories for Recreational Fishing License:

Residents and nonresidents under the age of 16

Residents age 65 or more (must carry proof of age)

Residents who are blind, paraplegic, a multiple amputee, or considered totally disabled by the Veterans or Social Security Administration or Railroad Retirement Board (must carry proof of disability)
